#### 4. CLINICAL PARTICULARS

##### 4.1 Therapeutic indications

LOCAL HEALTH ACTIVATED CHARCOAL supports the digestive function.

##### 4.2 Posology and method of administration

Adults 18 years and older: Take one to two vegecapsules up to three times daily after meals.

##### 4.3 Contraindications

- Hypersensitivity to the active ingredients or to any of the excipients listed in section 6.1.
- Patients with intestinal obstruction.

##### 4.4 Special warnings and precautions for use

- Caution is advised in patients with decreased peristalsis.
- Activated charcoal reduces systemic exposure to many medications, including those that undergo enterohepatic recirculation, regardless of the route of administration, co-administration should be avoided.

##### 4.5 Interaction with other medicines and other forms of interaction

- The absorptive capacity of activated charcoal may be lowered by alcohol.
- Activated charcoal may reduce the clinical effects of oral contraceptives.
- Syrup of ipecac is inactivated by activated charcoal.
- Activated charcoal reduces systemic exposure to many medications (e.g. acetaminophen, aminophylline, amiodarone, atenolol, carbamazepine, dapsone, digoxin, disopyramide, fluoxetine, indomethacin, moxifloxacin, nadolol, phenytoin, phenobarbital, piroxicam, quinine, sotalol, theophylline, tricyclic antidepressants, valproate, and verapamil), including those that undergo enterohepatic recirculation, regardless of the route of administration, co-administration should be avoided.

##### 4.6 Fertility, pregnancy and lactation

Safety during pregnancy and lactation has not been established.

##### 4.7 Effects on ability to drive and use machines

No studies on the effects on the ability to drive or use of machinery have been performed. Patients should exercise caution before driving or using machinery until they are reasonably certain that LOCAL HEALTH ACTIVATED CHARCOAL does not adversely affect their performance.

##### 4.8 Undesirable effects

###### Gastrointestinal disorders

Frequent: constipation, black stools, abdominal pain, bloating, flatulence.

Frequency unknown: gastrointestinal obstruction.

##### Reporting of suspected adverse reactions

Reporting suspected adverse reactions after authorization of the medicine is important. It allows continued monitoring of the benefit/risk balance of the medicine. In the event of an overdose, undesirable effects as listed in 4.8 can be precipitated or be of increased severity.

Treatment of overdose is symptomatic and supportive.

**1. What LOCAL HEALTH ACTIVATED CHARCOAL is and what it is used for**

LOCAL HEALTH ACTIVATED CHARCOAL supports the digestive function.

**2. What you need to know before you use LOCAL HEALTH ACTIVATED CHARCOAL**

A varied diet is the most effective and safe way to achieve good nutrition, health, body composition as well as mental and physical performance.

**Do not use LOCAL HEALTH ACTIVATED CHARCOAL:**

- If you are hypersensitive (allergic) to any of the ingredients listed in section 6.
- If you have an intestinal obstruction.

**Warnings and precautions**

Consult with a healthcare practitioner prior to using LOCAL HEALTH ACTIVATED CHARCOAL, especially if you have a medical condition.

Consult a healthcare practitioner prior to use:

- If you have decreased peristalsis.

**Children and adolescents**

LOCAL HEALTH ACTIVATED CHARCOAL is not recommended for individuals below the age of 18 years.

**Other medicines and LOCAL HEALTH ACTIVATED CHARCOAL**

Always tell your healthcare practitioner if you are taking any other medicine (this includes complementary or traditional medicines). Not all possible interactions with other medicines may be included in this leaflet. Consult with a healthcare practitioner prior to use if you are taking any other medication, as LOCAL HEALTH ACTIVATED CHARCOAL can alter their effectiveness.

Consult a healthcare practitioner prior to use if you are taking any of the following: oral contraceptives, ipecac, alcohol.

Activated charcoal reduces systemic exposure to many medications (e.g. acetaminophen, aminophylline, amiodarone, atenolol, carbamazepine, dapsone, digoxin, disopyramide, fluoxetine, indomethacin, moxifloxacin, nadolol, phenytoin, phenobarbital, piroxicam, quinine, sotalol, theophylline, tricyclic antidepressants, valproate, and verapamil), including those that undergo enterohepatic recirculation, regardless of the route of administration, co-administration should be avoided.

**Pregnancy, breastfeeding and fertility**

If you are pregnant or breastfeeding, think you may be pregnant or are planning to have a baby, please consult your doctor, pharmacist or other healthcare practitioner for advice before using LOCAL HEALTH ACTIVATED CHARCOAL.

**3. How to use LOCAL HEALTH ACTIVATED CHARCOAL**

Do not share medicines prescribed to you with any other person. Do not exceed the daily recommended dosage. Always use LOCAL HEALTH ACTIVATED CHARCOAL exactly as described in this leaflet or as your healthcare practitioner has instructed. Check with your healthcare practitioner if you are not sure.

Adults 18 years and older

Take one to two vegecapsules up to three times daily after meals, or as recommended by a healthcare practitioner.

**4. Possible side effects**

LOCAL HEALTH ACTIVATED CHARCOAL can have side effects. Not all side effects reported for LOCAL HEALTH ACTIVATED CHARCOAL are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking LOCAL HEALTH ACTIVATED CHARCOAL, please consult your doctor, pharmacist or other healthcare practitioner for advice. If any of the following happens, stop using LOCAL HEALTH ACTIVATED CHARCOAL and tell your doctor or pharmacist immediately, or go to the casualty department at your nearest hospital: swelling of the hands, feet, ankles, face, lips and mouth or throat, which may cause difficulty in swallowing or breathing, rash or itching, fainting. These are very serious side effects. If you have them, you may have had a serious reaction to LOCAL HEALTH ACTIVATED CHARCOAL. You may need urgent medical attention or hospitalisation.

**Frequent:** constipation, black stools, abdominal pain, bloating, flatulence.

**Frequency unknown:** gastrointestinal obstruction.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

**Reporting of side effects**

If you experience side effects, inform your doctor or pharmacist. - Protect from moisture and store at or below 25 °C.
- KEEP OUT OF REACH OF CHILDREN.
- Store in the original container and keep the container tightly sealed.
- Do not use after the expiry date stated on the label.
- Return all unused LOCAL HEALTH ACTIVATED CHARCOAL to your pharmacist.
- Do not dispose of unused LOCAL HEALTH ACTIVATED CHARCOAL in drains or sewerage systems (e.g. toilets).
